The top ten countries contributing to this influx include Mexico, India, Canada, El Salvador, China, Peru, Venezuela, Brazil, Vietnam, and the Philippines. In 2022, nearly 300,000 foreign-born individuals resided in Utah, with three- quarters of this population settled in Salt Lake and Utah Counties.

BYU's Professional Planning Studio partnered with the Tolikan Chapter of the Navajo Nation to create a land use plan focused on housing, infrastructure, and economic development, while preserving Diné culture and values. The University of Utah developed a neighborhood plan for Granite Legacy in South Salt Lake, aiming to enhance livability and sustainability through community engagement and strategic improvements. Meanwhile, Utah State University collaborated with South Salt Lake City and TreeUtah to identify optimal tree planting locations, considering factors such as urban heat, biodiversity, and human health.

Roads, cultivated fields, fences, waterways and many other similar disturbances can thwart these natural movements. However, through proper planning, wildlife corridors can remain intact at a scale that will benefit multiple wildlife populations as they move across the landscape from one area to another.
