

I remember whiling away several hot Saturday evenings at Derks Field with my dad in the late 1980s. At the time, Salt Lake's storied ballpark was home to the Trappers, and they were winning often. Although it was old and shabby by the time I started paying attention, Derks Field had a magic ingredient: the view of the Wasatch Front from home plate was among the best in professional baseball. In 1993, Derks Field was torn down and replaced with a new state-of-the-art ballpark that bore several different names and hosted two professional clubs, the Buzz and the Bees, as well as the Utes baseball team.

Utah Legislative Timelines and Deadlines Affecting Land Use

Existing Deadlines from Prior Years' Bills

- December 31, 2025: Station area plans due for existing public transit stations (2022 HB 462)
- December 31, 2025: Add water use & Conservation element to General Plan (2024 SB 110)
- July 1, 2030: Secondary water meters must be installed or else fined (2022 HB 242)

New Deadlines from 2025 Bills

- May 7, 2025: General effective date for new law from bills pass in 2025 session
- August 1, 2025: Revised initial MIH report due for safe harbor provision (HB 37)
- October 15, 2025: UDOT & SLC to report on mobility & environmental impact analysis on highway reduction strategies in SLC
- December 31, 2025: GOPB will adopt a state housing plan (HB 58)
- January 1, 2026: Building officials must meet new qualifications (HB 58)
- July 1, 2027: Certain Cities must include water conservation as element in determining water rate charged for at least the highest usage block (HB 274)
- July 1, 2027: All cities in MPOs must update General Plan traffic circulation impediments (SB 195)
- July 1, 2030: Secondary water provider must charge lowest rate to those growing food (HB 274)
