More than 400 planners, students, and community leaders convened on October 9-10, 2025, in Salt Lake City for the American Planning Association Utah Chapter Fall Conference, held at The Gateway's Depot and Megaplex Theatres. The conference theme—Utah: The State of Planning—focused on how the planning profession is responding to rapid growth, technological change, and evolving community needs across the state. These attendees were welcomed by Salt Lake City Mayor Erin Mendenhall and heard keynote speeches from Mitchell Silver and Corrin Wendell. Each spoke about their experiences working on various projects and emphasized the importance of accessibility and looking for areas where we can use planning to help broad swaths of community interests.

REMEMBERING TODD BLACK

Todd Black was Eagle Mountain City's Wildlife Biologist & Open Space Manager for four (4) years, until his untimely passing on September 12, 2025. It is obviously not common for a city to have a staff wildlife biologist, but in his relatively short time with the city, he accomplished so much. He carefully managed Eagle Mountain's vast amounts of open space. He was instrumental in the establishment of the 2025 Eagle Mountain City Natural Open Space & Wildlife Habitat Management Plan. He was responsible for erecting hundreds and likely thousands of feet of fencing to protect open space.

Utah Legislative Timelines and Deadlines Affecting Land Use

Existing Deadlines from Prior Years' Bills

- December 31, 2025: Station area plans due for existing public transit stations (2022 HB 462)
- December 31, 2025: Add water use & Conservation element to General Plan (2024 SB 110)
- July 1, 2030: Secondary water meters must be installed or else fined (2022 HB 242)

New Deadlines from 2025 Bills

- December 31, 2025: GOPB will adopt a state housing plan (HB 58)
- January 1, 2026: Building officials must meet new qualifications (HB 58)
- July 1, 2027: Certain Cities must include water conservation as element in determining water rate charged for at least the highest usage block (HB 274)
- July 1, 2027: All cities in MPOs must update General Plan traffic circulation impediments (SB 195)
- July 1, 2030: Secondary water provider must charge lowest rate to those growing food (HB 274)
